April 15, 2008, at Gallop Senior Center in Columbus.

The Atlanta Area Chapter was founded by Rosebuds Billie Ruth Bird and Nancy Klotz on June 8, 2008, at the Sue Kellogg Library in Stone Mountain, Georgia.

Nell Young, Georgia State Director, conducted the chartering ceremony for both chapters.

ARRA'S 10TH CONVENTION A GREAT SUCCESS!

The 89 Rosies, Rosebuds, Rivets, and guests who registered for the 10th annual ARRA Convention—plus a number of others who dropped in for a single event without registering for the whole convention—all had an exhilarating and unique experience. The Baltimore (Maryland) Chapter, whose President is Mary Nichols, was host to the event. It was held at the Berkshire Marriott Hotel, with side trips to other places of interest.

Rosie and Rivet Julia and Carl Yoder served as Convention Chairmen, coordinating the registration, program events, and transportation to the meeting sites outside the hotel, including their own airport shuttle service for attendees. Other key personnel included Debi Wynn and her dramatic team, who presented their original Rosie musical on Friday evening, and Rosebud Donna Campbell and her parents, Rosie and Rivet Loretta and Charles Simon, who prepared and served the Saturday luncheon at the Glenn L. Martin Aviation Museum, as well as dinner at the USO-type celebration/dance on Saturday night—complete with a 10th anniversary cake! Results of the business session are included below.

Summary of Business Session, ARRA Convention 2009

The Convention body voted to accept the recommendation of the year-long feasibility study committee, that ARRA discontinue the pursuit of placing a Rosie the Riveter monument on The Mall in Washington, D. C., for the following reasons:

1. The National World War II Monument Committee has declared the Monument finished and will not accept any additional art work as part of the Monument.

2. To place a monument elsewhere on The Mall or other government property would require a minimum of \$100,000 and an act of Congress authorizing it.

This action by the body does not preclude ARRA's considering placement of a monument elsewhere.

The Convention assembly also approved two by-law changes. The first involved increasing the membership fee, effective January 1, 2009, as follows:

Rosie membership fee, inside the U.S.,
remaining at \$10

Rosie membership fee, outside the U. S.,
increased to \$30

Rosebud membership fee, inside the U.S.,
increased to \$20

Rosebud membership fee, outside the U. S.,
increased to \$30

(Overseas membership fees are set to offset the higher postage costs for newsletters and other items.)

The second bylaw change approved a new membership category, that of 21st Century Rosies. This membership is available to women who are actively employed or self-employed, or who have been employed, in a job that before World War II was considered to be almost exclusively a man's job. There will be no Rosebuds or Rivets in this category. 21st Century Rosies may not vote or hold office. Lifetime membership fee for this membership is \$50.

OUR PRESIDENT URGES. . .

ROSIES AND VETERANS - HAVE YOU LISTED YOUR NAME?

Anyone who helped win WW II, either a veteran or an American on the home front, is eligible for the Registry of Remembrances of the National WW II Memorial in Washington, D. C. You may enter your own name, or the name of someone you wish to honor for their service during the war. The Registry of Remembrances is accessible on site at the Memorial, or online. Registration is free.

Names may be entered into the Registry online. To register online, go to www.wwiimemorial.com. Click on the "WWII Registry" button on the left and follow the instructions.

Names may also be entered by mail. You may download a form, complete it, and mail it to WWII Memorial Processing Center, P. O. Box 186, Calverton, NY 11933-0186.

American Rosie the Riveter Association®

(Working Women of World War II)

WHAT IS ARRA? The American Rosie the Riveter Association is an organization established to honor the contribution of women workers on the home front during World War II and to promote patriotism and responsibility among all Americans.

WHO MAY BELONG? Women whose work was designed to contribute to the war effort (including women who did volunteer work) and their female descendants are eligible for active membership. Spouses and male relatives may become auxiliary members by attending an official meeting of the Association, either local or national.

Women who performed the work are known as **Rosies**. Their female descendants are known as **Rosebuds**. Male auxiliary members are known as **Rivets**.

A woman is eligible for membership as a **Rosie** if her work or volunteer services occurred during 1941-1945 and consisted of **any one** of the following:

1. Employment of any sort in an industry or government agency that was directly related to the war effort, **or**
2. Employment (or self-employment) in a capacity usually held by a man, thus releasing a man for military duty, **or**
3. Participation on a sustained basis in one or more volunteer activities related to the war effort.

Examples of qualifying work are: work in any

capacity in a munitions plant, airplane manufacturing plant, shipyard, etc.; work for the Department of Defense, local rationing board, etc.; work as a truck driver, service station operator, etc.; independent work, such as farming; or volunteer work, such as collecting critical materials, rolling bandages, serving with USO or Red Cross, etc. Work that was customarily done by women and was not related to the war effort does not count.

Rosebuds are eligible for membership if their mother, grandmother, etc., was eligible to be a Rosie, no matter whether she is living or deceased, and regardless of whether she was a member of the Association or not.

WHAT DO MEMBERS DO? Members are **not** required to attend meetings or pay annual dues. They are invited to attend a national Reunion/Convention each year, and they may attend meetings of a Chapter in their locality. Rosies are invited to share their experiences both verbally and in written form, to become a part of the legacy of the working women of World War II. Members receive newsletters about the Association's activities on a regular basis.

All members are awarded a **certificate** honoring working women of World War II.

HOW MAY I JOIN? Rosies and Rosebuds complete and return the form in the next column. Rivets join by attending a meeting and filling out the form. Rivets pay no membership fee.
